Champions Among Us:

Fighting for Increased Personal Care Services Funding



Stephen Hoppy, 52, proudly talks about his career as a successful business entrepreneur. The job took him all over the country and gave him the chance to experience living in Myrtle Beach, SC; Atlanta, GA; Rochester, NY; and New York City, NY.

In 2009, all of that changed for Stephen. Complications from back surgery to treat scoliosis caused paralysis from the waist down. He moved to Hazleton, PA to be close to his extended family and remained as independent as possible until contracting COVID-19 last year.

"I ended up getting COVID so bad that I nedded a tracheostomy and a ventilator," said Stephen, who spent 10 months in the hospital. "I actually died twice, but they brought me back."

Following his discharge, the lasting effects of COVID made Stephen's daily life difficult without support. Now he relies on home health aides to help with getting out of bed, showering, and dressing. However, his shifts often go unfilled

due to the shortage of care professionals throughout PA.

"A lot of these services are funded by

Medicaid, and reimbursement rates aren't even coming close to keeping pace with what other employers are paying," said BAYADA Area Director of Government Affairs **Laura Ness**.

According to the Pennsylvania Homecare Association, the demand for home health aides is expected to grow by 29 percent by 2028, leaving PA short by nearly 75,000 aides. To meet that demand, they are lobbying the state for a 15 percent wage increase to attract more people to the profession.

Encouraging others to share their voice

"People don't realize how important these home health aides are. Without them, I couldn't do anything," said Stephen, who willingly shared his story on WOLF Fox 56 news. "But aides are hard to find because they can make much more working in the restaurant or retail industry."

Stephen encourages those with disabilities to use their voice to fight for the services they need. He can often be found giving motivational speeches at local rehabilitation facilities, and he is writing a book detailing his challenges with scoliosis and beating COVID-19.

"I tell it like it is," said Stephen. "If somebody needs help to tell their story, just ask me and I'll be there."

Do You Need an Elder Law Attorney?



An attorney certified in elder law can help you and your loved ones navigate complex legal issues that affect an older or disabled person, including issues related to health care, long-term care planning, guardianship, retirement, social security, Medicare, and Medicaid.

They help by:

- Evaluating the client's needs relating to federal tax,
 Social Security, Medicare, Medicaid, and property laws
- Preparing trusts and wills
- Determining the best way to pay for long-term health care, including private duty home care
- Assisting with disability planning, including use of durable powers of attorney, living trusts, and living wills for financial management and health care decisions
- Setting up conservatorships and guardianships
- Offering counseling on the distribution of public and private retirement benefits, survivor benefits, and pension benefits
- Helping the client and their family make difficult decisions, such as those related to end-of-life care

What are your options if you can't afford an elder law attorney?

Some dedicated elder law firms have aging life care professionals—also known as geriatric care managers—within their practice. These highly skilled and resource-informed non-attorneys can offer many additional services at a significantly lower rate than an attorney's hourly fee. Aging life care professionals are typically social workers or nurses who have access to in-depth information and resources on other services or programs.

You can also check with your local Office on Aging or search the internet for local and state agencies that may be able to help you.

The National Academy of Elder Law Attorneys is a professional association of attorneys who are dedicated to improving the quality of legal services provided to people as they age and people with special needs.
